

# End-User License Agreement (EULA) for Lagom WHMCS Client Theme

This End-User License Agreement ("Agreement") is a legal agreement between you ("Licensee" or "you") and RS Studio Paweł Bis ("Licensor"), hereinafter referred to as "RS Studio," regarding the Lagom WHMCS Client Theme ("Software"). By downloading, installing, or using the Software, you agree to be bound by the terms of this Agreement. If you do not agree to these terms, do not install or use the Software.

## 1. License Grant

### 1.1. Scope

- Licensor grants you a non-exclusive, non-transferable, limited license to install and use the Software solely for your own personal or business use as per the terms outlined in this Agreement.

### 1.2. Backup Copy

- You may create one backup copy of the Software solely for archival purposes.

## 2. Restrictions

### 2.1. Permitted Modifications

- You are permitted to modify files located within the **template folder** for your own personal or business use to customize the appearance and user interface of the Software.

### 2.2. Prohibited Actions

- You may **not** modify, adapt, or reverse-engineer any files located in the **addon folder**, which are encoded and manage licensing and backend functionalities.

- Redistribution, sublicensing, rental, leasing, or resale of any part of the Software is strictly prohibited.
- Removal or tampering with license validation mechanisms within the addon folder is not permitted and will lead to license termination.
- All graphics, icons, and other digital assets included with the Software may **only** be used within the theme as installed on the licensed WHMCS installation. These assets may not be copied, distributed, or used outside of the licensed environment where the Software is installed.
- You are permitted to install **only** the version of the Software currently available for download in your account. Installing a version not authorized in your account, such as a version released after your license expired without renewal, may result in immediate license cancellation.

### 2.3. Non-Transferable License

- This license is non-transferable. The Licensee is prohibited from transferring, selling, or assigning the rights granted under this Agreement to any third party.

### 2.4. License Protection

- Attempting to bypass, modify, or disable any license protection mechanisms within the addon folder will result in immediate termination of this license and the Software.

## 3. Ownership and Intellectual Property

### 3.1. Ownership

- The Software is licensed, not sold. RS Studio retains ownership of all intellectual property rights in the Software. This Agreement does not grant you any ownership interest in the Software.

### 3.2. Copyright and Trademarks

- All trademarks, logos, and copyright information contained in the Software must remain intact and unmodified.

## 4. Updates and Support

#### **4.1. Annual License**

- Purchasing an annual license includes access to technical support and updates for one year. Renewal fees apply for each subsequent year as per the current pricing.

#### **4.2. Lifetime License**

- For lifetime licenses, access to technical support and updates is also provided for one year, with optional renewal thereafter.

### **5. Limitation of Liability**

#### **5.1. As-Is Basis**

- The Software is provided "as is" without warranty of any kind. RS Studio disclaims all implied warranties, including warranties of merchantability, fitness for a particular purpose, and non-infringement.

#### **5.2. Liability Limitation**

- To the extent permitted by law, RS Studio will not be liable for any indirect, incidental, special, or consequential damages (including lost profits or business interruption) arising from the use or inability to use the Software.

### **6. Termination**

#### **6.1. Termination by Breach**

- RS Studio may terminate this Agreement immediately if you fail to comply with any term or condition in this Agreement.

#### **6.2. Effect of Termination**

- Upon termination, you must cease all use of the Software and destroy all copies of the Software in your possession.

#### **6.3. Legal Consequences of Unauthorized Distribution**

- Unauthorized resale, redistribution, or transfer of the Software is a violation of this Agreement and may result in legal action. RS Studio reserves the right to seek damages, injunctive relief, and any other remedies available under applicable law to protect its intellectual property rights.

## 7. Governing Law

This Agreement will be governed by and construed in accordance with the laws of the jurisdiction in which RS Studio is located, without regard to conflict of laws principles.
